Executive Summary

Management

We are planning to collocate our Bitcoin mining machines with Crypto LLC, which has an excellent machine management team. The work we are going to be doing for Private Investigators is baseline paralegal work which is going to be sourced out from my Alma Mater, the University of San Diego Paralegal Program, which is an ABA Curriculum Approved Training Program. We plan on doing our direct work for Licensed Pro Bono Attorneys as supervisors.

Customer Problem

We want to work with seasoned Bitcoin Miners to perpetually fund our Sex-Trafficking Victim Advocacy. Bitcoin Mining is a great perpetual funding source moving into NVIDIA GPU hosting because Bitcoin can simply be sold and no marketing needs to be done. We can develop a marketing plan as we move into GPU hosting which will increase our monthly profit about 4x, and this is how we plan on funding our Pro Bono Crime Victim Advocacy Work!

Product/Services

The main value proposition is that we will profit from the approximately \$0.04/kWh electricity price in North Dakota at the 8 MegaWatt Facility being developed by Crypto LLC, with whom we are partnering to collocate our mining equipment at their Mining Farm.

Target Market

Simply put, Bitcoin is easy to sell. Mining it efficiently with Crypto LLC will fund our work in a mission field where the innocent are destroyed by horrible people every day, and they need groups like ours to fight for them.

Business Model
